- 200718 Pumping station, Chazey Road, considered to be out of keeping with the surrounding properties and too near to the road. Alistair to write objection on behalf of WADRA. - Action: Closed
- Concerns exist regarding Kiers proposals, and supported by the Environment Agency, regarding bore holes and waste water management at MPF. The committee fear this will cause contamination to enter the main water supply. Alistair to contact Thames Water to flag concerns. **Action: Closed**

# 1186. Mapledurham Playing Field Pavilion:

Nigel Stanbrook has asked the MLTC to re-allocate £1,000 set aside for disabled toilets but no longer needed, to be used to buy kitchen equipment instead. This to include a hob, fridge and oven. Elisa is liaising with Nigel. **Action: Elisa ongoing** 

#### 1187. Deed of Dedication

No updates have been provided from Chris Brooks to repeated requests for progress to implement a DoD at MPF. Sticking points concern existing licenses and granting of future licenses. WADRA has spoken to David Sharman from Fields in Trust and established that no-one has contacted him or FiT since March'20. Elisa to chase up with Mr Brooks as this is now long overdue. **Action: Elisa** 

# 1188. Storage at MPF

No updates received from Andy Lockwood or Daniel Mander regarding storage at MPF. Elisa to chase up with both. **Action: Elisa** 

## 1189. MPF Pavilion Opening Event

Pavilion unlikely to open until Jan/Feb'21 earliest subject to the pavilion refurbishment being completed and signed off by the building inspector. WADRA proposing to hold a low key event with light refreshments. **Action: Ongoing**

# 1191. School Streets around MPF

No satisfactory response received from The Heights regarding an application for School Streets to be applied for in the immediate vicinity of the new school site at MPF. The committee agreed that it takes time to set these up and asked the question "why not put them in now?" If in place before the school opens, parents will accept restrictions as de facto. If the school applies after the new site opens, WADRA believes parents will resist and fight against such an initiative. Martin to draft a letter to be sent from Elisa to Esme Tiplady, Karen Edwards and Nick Waldon to chase this matter and to request a meeting takes place before Xmas to discuss.
