## 1282. MPF/A4074 Safety Concerns

Concerns were expressed regarding the apparent contravention of planning consent and boundary paths. It was also felt that Kier should not continue to be a part of the Considerate Constructors scheme due to recent inconsiderate actions such as very early starts, loud noises etc.

Serious concerns were expressed regarding A4074 keep left signs/restricted road width, increased uncontrolled parking in local roads, width of MPF access road, kiss-n-drop working and perceived loss of parking spaces in MF car park. Further question to be put to RBC regarding what are they doing for people/residents who are already here living in the area?

### 1284. Mapledurham Playing Field update

<u>Community car park works</u> to be carried out from Monday 5<sup>th</sup> – Friday 23<sup>rd</sup> July outside of school holidays. During this time the carpark will be closed to public vehicles but pedestrians & cyclists can still access the site from Upper Woodcote Road. During this period, RBC will apply for a temporary traffic regulation order (TTRO) for one side of Hewett Avenue (220m of roadside directly abutting residential properties) and notices will be put up over the next few weeks to reflect this advice.

<u>Sports pitch works</u> - Agripower have now completed the installation of the secondary sand groove drainage, veritidraining (work to de-compact soil), 1<sup>st</sup> laying of sand top dressing and applying an overseed & feed to the area. Follow on works are now to be programmed to comply with sport pitch specifications. The next step is to apply two further sand dressings, weather depending we hope to take place in August. As before this will be a tractor / trailer operation and the area is able to be walked on/used by members of the public. We will also be able to access the fields through the community car park.

Trim Trail installation work commenced Tuesday 15<sup>th</sup>June.

# 1285 Storage Compound

Andy Lockwood confirmed a 2m fence to be installed around the football store to create a new small open fenced storage area  $10m \times 6m$  adjacent to the shed to store new football goals for use on the new sports pitches. Running the fence in front of the shed will also reduce balls being kicked against the metal shed (which then reverberates like a drum), make climbing onto the shed and disturbing neighbours more difficult along with providing secure storage space for the football club. Installation week commencing  $12^{th}$  July.

### 1286. MPF Pavilion

Kitchen equipment delivered but oven needs to be changed from 3 phase to single phase. Elisa will take care of this.

- CTFC will be providing £1000 towards the cost of equipment
- Trish Goble is going to provide tables for the centre of the kitchen to prep food on and equipment like saucepans, bins, buckets, utensils and baking trays etc.
- Stewart and Gitta Bartlett have donated some equipment and installation costing about £3000
- MLTC will not be donating any money towards the kitchen.

## 1287. Dog Walkers

A new Dog Walker group/association has been formed by Elisa on social media. A committee member to take responsibility for encouraging dog walkers to join the group to help protect freedom of use on MPF without dogs having to be kept on leads etc. Hayley to write piece for the website.

### 1288. Community Hub - Thursday Afternoons

This will be a key part of WADRA's fundraising activity going forward. All information for getting a Hygiene 2 Certificate confirmed. RBC have advised we may not need to register as a food business which makes things easier. We will be looking to sell hot and cold drinks, and low risk food that can be kept at room temperature, such as cakes, biscuits, crisps etc. We will look into selling packaged ice creams in the summer. Kate Angwin has put forward some good ideas for activities that will get people into the pavilion. WADRA will need to purchase insurance for the next year to run events.

#### 1289. Issues with Kier

Elisa has received an unsatisfactory response now from Kier site foreman, Robert Walsh. She is now planning to write to Considerate Constructors to request Kier are struck off from their scheme.

Elisa still pursuing details regarding the DoD from Chris Brooks in order that our legal adviser can review and advise of any perceived issues. This is particularly pertinent to the clause about 5% being kept back by RBC.

## 1295. Grey Waste Bins

John has been chasing the local councillor and RBC regarding inconsistent waste bin collections, lack of timely, available slots at the Reading Tip and for evidence as to why the 240l grey bins were replaced with 140l bins, as there appears to be no sound business case for doing so. John has agreed to produce a draft "Blog" for approval by committee members which will aim to start others joining in the campaign to reinstate the larger grey bins and to improve slots at the tip.

## 1269. North Reading Safer Neighbourhood Forum

Martin sent a summary report prior to the committee meeting of the NRSNF meeting held 20<sup>th</sup> May'21. Key issues highlighted:

- Speed Watch & whether WADRA might be interested in buying a speed identification device (SID) with a view to encouraging local residents to be trained up as speed watch supporters. Devices cost approx. £200 each
- 2. Dog Walkers to be encouraged to join groups to walk their dogs together to help guard against the rise in dog theft cases.
- 3. Garden shed/garden room thefts on the rise. Residents encouraged to fit robust locks, CCTV or RING devices, install gravel drives and fit burglar alarms where practical.
- 4. Next NRSNF is 15<sup>th</sup> July'21 at 19.00hrs. Committee to raise concerns via Martin by 14<sup>th</sup> July latest.
